**COLUMBIA, S.C.** – The SCDC Inspector General released additional arrest warrants today for a former inmate charged with flying drones into McCormick Correctional Institution.

Quintin Alexander Douglas, 28, of Bethune, is charged with six counts of providing prisoners with contraband and six counts of criminal conspiracy. The charges involve flying drones carrying contraband onto the prison yard on six different days in 2023: May 5, May 31, June 5, July 1, July 2 and Aug. 11.

Douglas was [charged last week](#) with four counts of criminal conspiracy. Those charges involve flying drones carrying contraband into Broad River CI in April and July 2023.

At the time of his arrest, Douglas was [out on bond from charges](#) of flying drones carrying contraband into McCormick Correctional Institution in January 2023.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
