COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Hopkins woman on charges involving contraband at Lieber Correctional Institution.

Jirah Shakanah Walker, 30, is charged with possession of marijuana with intent to distribute, providing contraband to an inmate and criminal conspiracy.

Walker's charges involve driving a woman to Lieber and giving her a package to pass to an inmate during visitation. The contraband items included tobacco, jewelry and 85 grams of a substance that field tested positive for marijuana. The woman, Lynetta McCloud Mitchell, was also charged in the case.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
