**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for eight inmates in separate cases over the past month.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month.

The cases that came up for bond hearings in May include:

- Al Vonta Green, 31, assault and battery of a high and aggravated nature and second-degree assault and battery by mob at Turbeville CI.
- Niko Romon Taylor, 23, assault and battery of a high and aggravated nature and second-degree assault and battery by mob at Turbeville CI.
- Shaquan Thomas, 25, assault and battery of a high and aggravated nature and second-degree assault and battery by mob at Turbeville CI.
- Dominic Anthony Cole, 30, third-degree assault and battery at Broad River CI.
- Rasaun Maliek Hastie, 28, second-degree assault and battery by mob at McCormick CI, possession of contraband and carrying a concealed weapon at Lee CI.
- James Higgins, 54, trafficking in methamphetamines, possession of marijuana with intent to distribute and possession of cathinone, a synthetic controlled substance found in bath salts, at Kershaw CI. He is now housed at Lee CI.
- Jamaal Hinson, 33, attempted murder, carrying a concealed weapon and possession of a weapon during a violent crime at Lieber CI. He is now housed at Broad River CI.
- Reggie Ravon Manning Jr., 32, inmate carrying a concealed weapon and threatening the life of a public official at Broad River CI. Manning is now housed at McCormick CI.

The first three cases are connected, and the others are for individual crimes. They are different from disciplinary charges inmates might receive while incarcerated. These are criminal charges in circuit court.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
