**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a Summerville man on charges involving contraband at Lieber Correctional Institution.

Damien Rakari Anderson, 25, is charged with trafficking in methamphetamines, possession of marijuana with intent to distribute, providing contraband to an inmate and criminal conspiracy.

Anderson's charges involve a package filled with drugs and other contraband attached to a truck being driven into Lieber CI.

When he was arrested, Anderson was out on bond from [a previous arrest](#) in February, when he was charged with providing prisoners with contraband, possession of marijuana with intent to distribute and criminal conspiracy. Those charges involve attempting to fly a drone carrying contraband onto the prison yard at Lieber CI.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
