COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrant today for a Pacolet man on charges involving contraband at Livesay Correctional Institution.

Jomo Rashad Bailey, 48, is charged with criminal conspiracy. Charges against Bailey, a former SCDC inmate, involve communicating with a current inmate who was using an illegal cellphone to plan to introduce contraband into the prison.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
